In the event the Equipment is not timely returned to MECO, Lessee agrees and stipulates that it has a retail value of \$1,500 and agrees to pay such amount to MECO upon demand and, in addition, Lessee shall be deemed to have forfeited any amounts tendered as a deposit hereunder. Lessee agrees that in the event MECO is forced to institute litigation to recover any amounts due to it, MECO shall be entitled to also recover its reasonable costs and attorneys' fees incurred in such collection efforts.

MECO makes no representation or warranty as to the adequacy or the sufficiency of the Equipment for use by Lessee. Lessee acknowledges that he/she will have the Equipment inspected by his/her instructor for adequacy, suitability and/or sufficiency in connection with any class or other training exercise being undertaken. Lessee agrees that he/she will rely exclusively on the advise of his/her instructor in deciding whether to use the Equipment in connection with any such class or other training exercise. Lessee hereby agrees and acknowledges that under no circumstances will MECO be deemed responsible for any injury or harm incurred by Lessee as a result of his/her use of the Equipment in any class or other training exercise. **No refunds on gear purchased or rented after issued. It is the intent of the parties to this Rental Agreement that MECO be insulated and be held harmless from any liability or claim for injuries or other damages sustained by Lessee in any way relating to his/her use of the Equipment to the fullest extent permitted by law.** Under no circumstances shall MECO be held liable for damages for pain and suffering, actual damages, punitive damages, exemplary damages, consequential damages, incidental damages or other damages of whatever nature or kind.
